- As conferences, industry events, and general networking events are planned, we will send consultants to join the events, and identify local businesses that could benefit from our successful tender
- When we are required to provide travel or accommodation, we will use a local travel agent in Tasmania to make our booking. This will again, bring money back into the SME market in Tasmania
