GOODS AND SERVICES TEMPLATE HISTORY: VERSION 2024-01

1 About this document

This document logs changes to the suite of goods and services procurement template documents issued by the Office of the Crown Solicitor (**OCS**).

This document also logs changes to the Goods and Services Template Guide issued by OCS. (The guide explains how to draft goods and services procurement documents using the templates).

This document does not log changes to the following ancillary documents issued by OCS:

- this document;
- Goods and Services Clause Bank;
- Goods and Services Template Overview.

2 Template names, filenames and version numbers

Each goods and services procurement template within the suite has been allocated:

- a short name; and
- an OCS filename (which includes a version number).

Each time a template is updated by OCS, OCS will create a new version of the template. The updated template will be given a new file name. The short name for the template will remain unchanged.

Generally, the new filename for an updated template will be the same as the previous template filename *except for the last six digits*. The last six digits of a filename are the version number for the template – for example '2021-01'. The first four numbers are the calendar year in which the template was created (or modified). The last two numbers allow for the differentiation of template versions created (or modified) in the same calendar year. For example, if a template was updated three times during 2022, the filename for the 'third version' of the template would include '2022-03'.

If a template is updated in a *later* calendar year, the last two digits for the version number will be reset to '01' for the *first* version of the template created in the later calendar year.

Agencies drafting a procurement document using a goods and services template will need to allocate a 'unique' filename to that document. The agency allocated 'unique' filename should replace the OCS template filename in the document footer. To avoid confusion, an agency issuing a procurement document should not include the original OCS template filename. ***This is because a specific procurement document prepared by an agency using an OCS template is not a template.***

Warning:

The following templates must **not** be amended or altered by agencies in any way:

- the General Conditions of Contract;
- the Goods and Services SCC;
- the Consultant Services SCC.

In addition, agencies must **not** create their own versions of these documents.

Note: 'SCC' stands for 'Short Conditions of Contract'.
